to prosperity and security. Students need dedicated professionals in their classrooms, and teachers deserve professional pay and paycheck security. The unfunded mandates of No Child Left Behind encouraged teaching to test content and did not encourage best practices for students or teachers.

Rep. Biggert voted YES on No Child Left Behind and NO on extending student loans.

National Security: Scott wants the brave military men and women serving our nation to have our full support. But, he also knows that lasting peace and security will require diplomatic solutions.

Scott wants to close the Guantanamo Bay detention center because it negatively impacts this country's image abroad and does not make us safer. He seeks reform of the defense procurement process so that taxpayers get their money's worth while ensuring that our troops are well equipped and ready.

Rep. Biggert voted YES to authorize the Iraq war and NO on withdrawing troops. Biggert voted NO on combat pay bonuses for our troops.

Health Care: Scott believes that all citizens deserve access to quality, affordable health care. While the health care plan that recently passed Congress might not be perfect, it provides protection for people with pre-existing conditions, extends coverage to young adults, and halts many predatory insurance practices.

While there is still more to do, Rep. Biggert signed a letter calling for immediate repeal of the health care bill, which would force us back to square one. Biggert voted no on S-CHIP, and NO on health care reform. She has taken tens of thousands of dollars in campaign contributions from drug and insurance companies.

Endorsements: Scott has been endorsed by Circle of Friends for American Veterans, Citizen Action IL (the state's largest public interest group for social and economic justice), AFL-CIO, International Union of Painters and Allied Trades, and after Biggert's recent vote against assisting states to rehire teachers lost to budget cuts—the Illinois Federation of Teachers. Organizations representing carpenters, steelworkers, mechanics, transport workers, postal workers and others stand alongside Scott.

Message From Chair, Kim Savage

It's been a long, hot summer and political misinformation has continued to bounce around like a Superball. Health care. Bail outs. Campaign finance reform. Electronic voting machine flaws. Ethically challenged officials. The list is endless, making even the most savvy voters cringe and the average American withdraw from the process.

It is no secret that midterm elections are plagued by low voter turnout. This year, combined with twisted truths repeated in short sound bytes, more voters are indicating that they plan to sit out the election on November 2. Yes, they plan to stay home...or they plan to just vote out all incumbents because they are not getting the results they expect from their elected officials. Frustration with elected

officials and political shenanigans is palpable, but the more people abdicate their personal responsibility to elect others to represent them, the worse the situation gets and then it can't be fixed over night.

Knocking on doors this summer, I have frequently found voters confused about important issues facing us in Illinois as well as candidates seeking office. Here are a few key points that everyone needs to know as they consider their choices this year.

• American Recovery and Reinvestment Act (ARRA)

Myth: The ARRA failed to create jobs and restore economic growth.

Fact: Through March 31, 2010, \$8.3 billion was expended and 60,000 jobs were created or retained in Illinois.

• Wall Street Reform

Myth: Financial reforms will make it difficult for businesses to create jobs.

Fact: Clear rules and basic safeguards that prevent abuse and check excess will ensure that it is more profitable to play by the rules than to game the system.

• Jobs for Main Street Act

Myth: Democrats create an unfriendly business environment.

Fact: Jobs for Main Street Act provides incentives for businesses to hire unemployed workers.

• Patient Protection and Affordable Health Care Act

Myth: Health care reforms will negatively impact senior citizens and will cost Americans more.

According to a June poll, Scott Harper has a good chance to win this fall. The district is leaning 38% GOP, 32% Dem and 27% independent. Rep. Biggert's increasingly hard-right voting record has alienated more and more of the District's voters, persuading them to look with keen interest at Harper and his positions on the issues.

Jobs and the Economy: Scott sees that the answer to our economic malaise is jobs. He says we must close tax loopholes that send jobs over seas. A simplified corporate flat tax would ensure that corporations pay their fair share of taxes and that Main Street merchants have the capital needed to expand and hire. He believes real corporate oversight and accountability, community lending, and real fair trade/tariff agreements must be enacted to create long-term stability and growth.

Rep. Biggert voted NO on the Recovery & Reinvestment Act and NO on the Jobs bill. She is the ranking member of the Financial Services Subcommittee on Oversight and Investigation, yet she voted NO on mortgage restructuring and bankruptcy, NO on regulation and oversight of the country's financial system, and NO on monitoring TARP funds. Rep. Biggert was the single biggest recipient of Citigroup PAC funds in the first quarter of 2010.

Scott believes that the high-tech energy sector can create jobs, reduce dependence on foreign oil, and protect the earth. District 13, home to Argonne Labs, can lead the way in bringing science and industry together to strengthen the marketplace and broaden employment.

Biggert voted NO on renewable energy standards, NO on renewable energy credits for small business, and received just a 27% rating from the League of Conservation Voters.

Education: Scott advocates a quality, world-class public education system that will lead America and the world back
